Trenggalek (ANTARA) - PT. Sumber Mineral Nusantara (SMN) will certainly involve the central government, especially from Badan Geologi to conduct study related to environmental and water resources in its operational area of Trenggalek, East Java.

Let independent parties and experts do the study," he continued.

Handi emphasized that the presence of an investment if it is carried out in accordance with existing regulations or rules, will certainly provide many benefits.

Job vacancies, regional income, the growth of various new businesses, the increase in the local economy cycle, the growth in consumption levels, which in turn will reduce the number of poverty and develop the region.

SMN is also committed to being open and accepting constructive and beneficial input for the community. Togetherness in regional development is very necessary.

Companies also need to be monitored properly so that they operate according to the regulations.
